***** Kennel hours of operation are 8am-8pm 7 days a week. *****

Kennel agrees to exercise due and reasonable care, and to keep the kennel premises sanitary and properly enclosed.

The dog(s) is (are) to be fed properly and regularly, and to be housed in clean, safe quarters.

Owner understands and agrees that dog(s) charges are as follows, they will be charged for the 1st day no matter what time dog is dropped off, picked up by Noon on pick up day will not be charged for that day, picked up after Noon will be charged for that day.

Owner further agrees that pet(s) shall not leave the Kennel until all charges are paid to Kennel by Owner.

If the pet(s) become ill or if the state of the animal's health otherwise requires professional attention, Kennel, in its sole discretion, may engage the services of a veterinarian of its choosing, or administer medicine, or give other requisite attention to the animal, and expenses thereof shall be paid by Owner.

If dog is left for 7 days after agreed upon pickup day without owner notifying kennel it will be considered an abandoned dog and kennel owner can call the human society to pick the dog up.

It is understood by Kennel and Owner that all provisions of this Contract shall be binding upon both parties thereunto for this visit and for all subsequent visits. This Contract contains the entire agreement between the parties.
